4. QUALIFICATION FOR MEMBERSHIP

Any person who

- (a) has been proposed by one and seconded by another member of the Club;
- (b) has attained the age of eighteen years, or thirteen years or at the discretion of the Board in the case of an applicant for Junior Membership, shall be qualified to be elected as a Member of the Club.

5. CATEGORIES OF MEMBERSHIP

The following are the rights and privileges attached to each class of membership:

A. Category A Member

A Category A Member shall be entitled to all the privileges of membership. The words Category A Member when used in these Articles, when the context admits, shall include Life Members.

B. Category B Member

A Category B Member shall be entitled to all the privileges of membership except the use of the golf course playing facilities on Saturdays other than at such times and under conditions on Saturdays as the Board may determine.

C. Category C Member

A Category C Member shall be entitled to all the privileges of membership except the use of the golf course playing facilities on Saturdays and Sundays other than at such times and under such conditions on Saturdays and Sundays as the Board may determine
