## **PERTINENT INFORMATION FROM WGC ARTICLES OF ASSOCIATION**

### **4. QUALIFICATION FOR MEMBERSHIP**

Any person who -

- (a) has been proposed by one and seconded by another member of the Club;
- (b) has attained the age of eighteen years, or thirteen years or at the discretion of the Board in the case of an applicant for Junior Membership, shall be qualified to be elected as a Member of the Club.

### **5. CATEGORIES OF MEMBERSHIP**

The following are the rights and privileges attached to each class of membership:

#### **D) Category Junior Member**

A Junior Member shall be less than twenty years at the date of election and shall have the same rights and privileges as a Category A Member (for restrictions on Voting Rights see Article 54), subject to these Articles and to such limitations and restrictions as the Board may from time to time impose. A Junior Member may remain a Junior Member until the commencement of the year following the year in which the age of twenty-three years is attained.

#### **E) Provisional Junior Member**

A Provisional Junior Member shall be less than twenty years at the date of election and shall have the same rights and privileges as a Category B Member (for restrictions on voting rights see art. 28 (e) and 57, subject to these Articles and to such limitations and restrictions as the Board may from time to time impose. A Provisional Junior Member may remain a Provisional Junior Member until the commencement of the year following the year in which the age of twenty-three years is attained. A Provisional Junior Member may transfer to Junior Membership upon satisfying the Board that an acceptable level of golfing ability has been attained, providing always that a vacancy exists in that category.
